SUMMARY

The forum will focus on the theme, "Towards Industrialisation for Sustainable and Inclusive Development - Role of DFIs in SADC". This is in recognition of the prioritisation of industrialisation by SADC Heads of State as a key element towards the achievement of sustainable economic growth and development in the SADC region and enhancing the welfare of its peoples. The successful implementation of the regional industrialisation strategy will require massive investment across various industrial sectors. In this regard, financial institutions, and specifically DFIs, in tandem with the private sector, will play a critical role in mobilising the requisite financial resources.

The forum will therefore explore the role and experiences of national DFIs in supporting industrial development, inclusive of the small and medium enterprises sector (SMEs), and the successes and challenges that they have encountered. Given the adoption, both at regional and national levels of industrialisation as an economic growth enabler, it is imperative that DFIs play their mandated role specifically the mobilising of financial resources, and targeting these at key growth sectors to ensure the achievement

of national and regional development goals.

The debate at this forum should therefore shed light on the challenges and effective strategies of how the DFIs can help catalyse industrial growth in the SADC region.
