## **Objective**

The forum will focus on discussing "Sustainable Development Goals (SDGs) Implementation: DFIs as catalysts". The DFIs will play a crucial role in attaining the SDGs both in individual member states and on a regional basis. In addition, the G20 nations have made considerable financial resources available, through multilateral organisations, which can be accessed by DFIs in SADC as they fulfill their mandates.

#### **Speakers**

**Dr. Muyeye Chambwera** currently works for UNDP in Botswana as Technical Specialist on Sustainable Development, a position he has held since 2012. In this capacity, he provides technical support and advice to the Government of Botswana on Sustainable Development, including facilitating the process for a National Strategy for Sustainable Development and the integration of Sustainable Development into national and district planning. He is also involved in the process of domesticating the Sustainable Development Goals in Botswana, including facilitating dialogues with Local Authorities and the financial services sector.

Prior to his current position, Dr. Chambwera worked for the International Institute for Environment and Development (IIED) in London as Team Leader and Senior Researcher on the Economics of Climate Change, with a focus on Climate change Adaptation. In this role he coordinated policy-oriented research on Climate Change Adaptation in developing countries, covering the regions of Africa, Asia and Latin America, while also supporting global climate change scientific, policy and implementation processes. He was involved in the Intergovernmental Panel on Climate Change

(IPCC) 5th Assessment as a Coordinating Leading Author.

Before joining IIED, Dr. Chambwera spent 10 years working with the World Wide Fund for Nature (WWF)'s Regional Office for Southern Africa, responsible for policy and economics. His work involved working in several Southern African countries, with a specific focus on Zambia, Malawi, Zimbabwe and Mozambique.

Dr. Chambwera holds a PhD from Wageningen University (Netherlands), a Masters degree in Natural Resources Management from the University of Western Australia and a Bsc (Honours) degree from the University of Zimbabwe.

**Ms.** Loyiso Ndlovu is currently Executive Manager: Strategy, Policy & Marketing at the Land & Agricultural Development Bank of South Africa. A former Director of Infrastructure Firm, Bigen Africa and a former Executive member of Development Bank of Southern Africa and is also experienced in running her own consultancy.

She has worked in both private and public sector, and is well versed on Strategy development and human capital development in both sectors. She has broad experience in business strategy positioning across the sectors of Development Finance, Information Technology, and Print publishing and was also a part time UNISA MBA lecturer.

She has a passion for understanding the dynamics of the workplace and maximising people to achieve results.

**Mr. Andrew McRobert** is the General Manager of Portfolio Management and manages the credit risk, operations evaluation, loan management and portfolio reporting units at the Development Bank of Southern Africa (DBSA).

He is commercial banker specialising in insolvency and with nearly thirty years' experience in credit, portfolio risk management, lending and problem loans management, including more than 20 years as a development banker in the Asia-Pacific region.

He is also an experienced and internationally recognised writer and presenter of credit, lending and problem loans management training seminars, and an author of 3 books on problem loans and financial literacy. For more than 20 years, he has designed, written and presented a large number of training programs (listed in "Training Experience and Courses"). He has presented these in more than 15 countries in the Asia-Pacific region, and in about 5 countries in the Middle East.

He has a demonstrable track record of identifying and implementing recovery strategies for complex non-performing investments and loans in Australia and across Asia. He is experienced in conducting due diligence assignments, highlevel problem resolution negotiations and team building in credit and portfolio risk management. He also has experience as a bank mediator for resolution of complex non-performing loan negotiations; and as a mentor for less experienced finance sector professionals.

**Dr. Lufeyo Banda** is a national of Zambia. He earned his PhD in Economics from the University of Cape Town in South Africa in 2010. A Development Economist, Dr. Banda has previously worked in Washington DC at the World Bank/ IMF as a scholar, and was a relationship manager in the corporate division of Standard Chartered Bank, and as a Development Finance Expert at the SADC Secretariat in Gaborone, Dr. Banda has also written policy papers on institution and corporate governance, development finance and over a period of ten years advised DFIs on issues of development finance, particularly those relating to Prudential Standards, Guidelines and Rating (PSGRS), resource mobilisation, and setting up of institutional framework for development finance institutions.
